For the privilege of participation in FYHBA Youth Hockey and other value received, the undersigned endorsers, promise and guarantee to pay **ALL TEAM PLAYER FEES ARE DUE IN FULL FOR THE 2017-2018 SEASON** by **January 31, 2018 by following the Payment Schedule or paid in full (for season fees) by September 30, 2017 in order to receive the Paid in Full Discount.**

In the event of nonpayment accrued after January 31, 2018, the entire balance remaining unpaid, with accrued interest thereon, shall at once become due and payable at the option of the FYHBA Board of Directors without notice or demand.

In the event of nonpayment of any amounts owing after January 31, 2018, the undersigned endorsers authorize any attorney at law or FYHBA board member to appear in any court of record of Sandusky County, Ohio, at any time after February 1, 2018, and waive the issuing and service of process and confess a judgment in favor of the FYHBA and against the endorsers, or either or any one or more of them, for the amount due and owing and interest then appearing due upon this note, together with cost of suit and to release all errors and waive all rights of appeal. Endorsers acknowledge that this agreement has either been brought to the attention of their legal counsel or that they have had the opportunity to do so.

The endorsers hereof waive presentment, demand, notice of dishonor, and notice of nonpayment and protest. The endorser has executed this instrument in the capacity of maker and guarantor regardless of the location of his/her signature.

WARNING: By signing this paper, you give up the right to notice and court trail. If you do not pay on time, a court judgement may be taken against you without your prior knowledge and the powers of a court can be used to collect from you regardless of any claims you may have against the creditor, FYHBA, for failure on its part to comply with this agreement, or any other cause.
